Each artist may interpret well-being as he/she feels, and this can be in any medium except photography and digital artwork. All artwork must be original (no copies) and have been executed since January, 2008. Nudes will not be accepted. **No jewelry or crafts may be submitted. Only one entry per artist is allowed.** Artwork exhibited in previous "Art of Well-Being" Exhibits cannot be exhibited in this year's show. Two-dimensional artwork should not exceed 48" in either direction, must be on stretched canvas or be framed, and **must have wire on the back for hanging.** Three-dimensional artwork should not exceed 48" in any direction or weigh over 30 pounds; no assembling will be done.

Artists are asked to insure their artwork while on display in the church's Gathering Area. The First United Methodist Church will not be responsible for loss or damage. All reasonable precaution will be taken in the handling of the artwork. No commission will be taken on sold artwork. All artwork will be displayed.
